QUIZ PHASES AND SCHEDULE

- The Quiz consists of a single main phase which will take place on Aug 23, 2020 at 12:00 PM to 12:40 PM. The quiz submitted after 12:40 PM shall not be taken into consideration.
- In the scenario in which two or more Participants have identical results, they will enter a tiebreaker stage. The results of the tiebreaker stage will be made public on the social media and announced directly to the candidates in the same situation via email.
- The Quiz will be held online on the (☒).
- The Quiz will be held exclusively in English, and includes the MCQ based questions from the Constitution of India.
- Quiz will include the 50 set of question.
- Quiz is of 40 minutes and will contain 50 questions, extension of time-limit would not be entertained at any cost.
- Quiz can be attempted only once, so make sure that you have a stable internet connection at your place of attempt.
- After the completion of the Quiz, you need to submit the Quiz. If in the desired time, the Quiz is not submitted, then it will not be considered as attempted.
- Each right answer would fetch you one mark. All questions are Multiple Choice Questions (MCQs). There will be 4 choices to each question, and only one of the choices from them would fetch you a positive mark.
